

**TOWN OF GREENWOOD  
MONTHLY BOARD MEETING  
MINUTES  
September 13, 2023**

The monthly board meeting for the Town of Greenwood was called to order by Chairman Mitchell Peters at 7:00 PM. All members present.

**Minutes** – Minutes were read by Clerk Jill Scheithauer. A motion was made by Sup. Travis Fuchs to accept the minutes of the August meeting; second by Peters. Motion passed.

**Treasurer's Report/Pay Bills** – A motion was made by Sup. Mike Wudi to pay the bills and accept the treasurer's report. Second by Fuchs. Motion passed.

**Public Input** – None.

**Road Updates:** We still have not received a response about moving the fiber optic on Lemke Creek Drive so graderman Kurt Bube can bury the last culvert. No updates on the River Road river bank issue. Peters will try and contact the DNR and Taylor County Land Conservation about fixing the bank.

- **Hetland Avenue Clean-Up** – After Peters spoke to J.J.'s Brushcutting, who currently charges \$150/hour, it was suggested that spend \$7500 (an amount to be revisited every year) to hire them to do right-of-way clearing starting at Hetland Avenue and continue throughout the township until the allotted yearly amount is spent. A motion was made by Wudi and seconded by Fuchs outlining this. Motion passed.
- **Disaster Relief** – Peters is working on finalizing the numbers and will be submitting the information to receive funding.
- **LRIP** – Wudi asked if anyone has looked into the LRIP funding. Peters has been reading up on it. It is a competitive grant that we would have to apply for. At this point it is unknown if the town would have to match funds in order to qualify.

**Other Business** – None.

A motion was made by Fuchs and seconded by Wudi to adjourn the meeting at 8:01 PM. Next meeting to be held on October 11, 2023. Meeting adjourned.
